

**A RESOLUTION TO AMEND THE REGULAR CITY COUNCIL MEETING
SCHEDULE AND LOCATION FOR CALENDAR YEAR 2009**

- WHEREAS:** The Mayor and City Council of the City of Dunwoody are required under the City Charter to hold regular monthly meetings and shall hold at least one meeting a month; and
- WHEREAS:** The Mayor and City Council for the City of Dunwoody find that the formation of a new city requires prompt action to fulfill their duties to the citizens and businesses of the City; and
- WHEREAS:** The Mayor and City Council of the City of Dunwoody have determined that in order to be a more effective governing body, they deem it necessary to authorize two scheduled business meetings a month, and hereby designate the Second and Fourth Monday of each month; and
- WHEREAS:** The Mayor and City Council of the City of Dunwoody have determined that the Tuesday immediately following a National Holiday that falls upon a Second or Fourth Monday shall instead be the date of the City Council Meeting in such instances; and
- WHEREAS:** The Mayor and City Council of the City of Dunwoody have determined that in order to be a more effective governing body, they deem it necessary to authorize one scheduled Work Session a month, and hereby designate the Third Monday of each month; should the Third Monday of each month fall on a National Holiday, the Work Session shall instead be on the Tuesday after the Third Monday of each month. The first read of an ordinance that requires two reads maybe read at any meeting designated as a work session.; and
- WHEREAS:** The Mayor and City Council of the City of Dunwoody may hold additional meetings, should the need arise; and
- WHEREAS:** All meetings of the City Council, ~~until such time as a permanent City Hall is designated, shall be held at the Dunwoody United Methodist Church, located at 1548 Mount Vernon Road, Dunwoody, Georgia 30338~~ are to be held at the Dunwoody City Hall.
- WHEREAS:** All meetings of the City Council shall be public to the extent required by law and the City Clerk or Designee shall give proper notice to the public of special meetings, as required by law.

NOW THEREFORE BE IT RESOLVED by the Mayor and Council for the City of Dunwoody that scheduled meetings of the City Council, during the calendar year of 2009, are to be held on the Second (2nd) and Fourth (4th) Monday of each month, and Work Sessions are to be held on the Third (3rd) Monday of each month, at ~~the Dunwoody United Methodist Church~~ the Dunwoody City Hall, effective this the 8th day of June, 2009.
