# BROOK RUN CONSERVANCY, INC. ARTICLES OF INCORPORATION

#### ARTICLE I.

The name of the Corporation is:

### BROOK RUN CONSERVANCY, INC.

#### ARTICLE II.

The Corporation is organized pursuant to the Georgia Nonprofit Corporation Code.

#### ARTICLE III.

The Corporation shall have perpetual duration.

#### ARTICLE IV.

The purposes for which the Corporation is formed are the following:

- (A) The Corporation is organized for the preservation and stewardship of land for ecological, recreational, scientific, historic, educational, agricultural, scenic or natural maintenance uses, exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code") including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Code (or the corresponding provision of any future United States Internal Revenue Law).
- (B) This Corporation is not organized and shall not be operated for pecuniary gain or profit. No part of the property or net earnings of the Corporation shall inure to the benefit of or be distributable to its directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article IV. No

substantial part of the activities of the Corporation shall consist of carrying on propaganda, or otherwise attempt to influence legislation to such extent as would result in loss of its exemption from federal income tax under Section 501(c)(3) of the Code, and the Corporation shall not participate in, or intervene in (including publication or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Code (or the corresponding provision of any future United States Internal Revenue Law).

#### ARTICLE V.

The affairs of the Corporation shall be managed by a Board of Directors. The number of Directors of the Corporation and method of election shall be set out in the bylaws.

#### ARTICLE VI.

The Corporation shall have no members.

#### ARTICLE VII.

The initial registered office of the Corporation shall be at 115 Perimeter Center Place, Ste. 170, Atlanta, Dekalb County, Georgia 30346. The initial registered agent of the Corporation at such address shall be Richard W. Jones.

#### ARTICLE VIII.

(A) No Director of the Corporation shall be personally liable to the Corporation for monetary damages for breach of duty of care or other duty as a Director; provided, that this

provision shall eliminate or limit the liability of a Director only to the maximum extent permitted from time to time by the Georgia Nonprofit Corporation Code or any successor law or laws.

(B) Any repeal or modification of Article VIII(A) by the Corporation shall not adversely affect any right or protection of a Director of the Corporation existing at the time of such repeal or modification.

#### ARTICLE IX.

The name and address of the incorporator is Richard W. Jones, 115 Perimeter Center Place, Ste. 170, Atlanta, Dekalb County, Georgia 30346.

#### ARTICLE X.

The mailing address of the initial principal office of the Corporation shall be as follows: 115 Perimeter Center Place, Ste. 170, Atlanta, Georgia 30346.

#### ARTICLE XI.

Upon the dissolution of the Corporation's affairs, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the Corporation, distribute, transfer, convey, deliver and pay over all of the assets of the Corporation then remaining in the hands of the Corporation to a governmental entity described in Section 170(b)(1)(A)(v) of the Code or to any other organization qualifying under Section 501(c)(3) of the Code as an exempt organization, to be used exclusively for charitable purposes, as described in Article IV hereof, and which is qualified to receive "qualified conservation contributions" within the meaning of Section 170(h) of said Code or the corresponding provisions of any future statute of the United States. In the event that, for any reason, upon dissolution of the Corporation the Board of Directors shall fail to act in the manner herein provided within a reasonable period of time, the Senior Judge of the Superior Court of Dekalb County, Georgia shall make such distribution,

exclusively upon the application of one or more persons having a real interest in the Corporation or its assets.
