### ITEM DESCRIPTION

Ratification of purchase orders for Bend Creek Road Storm Pipe Replacement Project

#### **BACKGROUND**

This project was originally to replace a damaged 48-inch diameter, circular storm water pipe located at 5602 and 5610 Bend Creek Road (See Attachment "A" sketch). The replacement was initiated due to a sinkhole and collapsed pipe adjacent to the residence at 5602.

The pipeline begins at 5610 and continues downstream through 5602 and two additional properties before emptying into a drainage ditch. As originally conceived the project scope involved excavating and replacing the visibly damaged sections of pipe at 5602 and 5610 including necessary site restoration. Three written quotes were obtained and a Purchase Order (00080) was issued to the low bidder, Blount Construction, for \$32,051.70 (See Attachment "B").

After starting construction we were informed by the adjacent property owner at 5620 Bend Creek about a new sinkhole caused by the deterioration of an upstream storm water pipe. Blount Construction was asked to provide a change order for an additional 20 feet of 48-inch diameter pipe and two headwalls. This work was considered Change Order Number 1 in the amount of \$13,279.70 (Attachment "C") and was incorporated into the project immediately as the sinkhole had caused a break in the water line to the house.

A second change order was required when the existing storm drain pipe at 5602 Bend Creek Road was removed and it was discovered that the downstream pipe was elliptical rather than circular and had a completely rusted out bottom. During the initial investigation the downstream segments could not be evaluated by video due to the collapse at 5602 and complete blockage with sediment at the downstream end. It was anticipated at the time that, if these inaccessible downstream segments were found to be in poor condition when uncovered during the replacement at 5602, the City would solicit bids for a separate contract to line the pipe. Lining the downstream segments was preferred over excavation and replacement to avoid removing landscaping and large hardwoods. However, upon excavating the pipe at 5602 it was discovered that the pipe transitioned from a round pipe at the inlet at 5610 Bend Creek Road to an elliptical pipe beneath the driveway at 5602. Because elliptical pipe cannot be lined, the only option became excavating and replacing the pipe downstream of 5602.

An additional 250 feet of 48-inch diameter pipe was installed on an emergency basis due to open trenches in the backyard of 5602 Bend Creek and the potential for flooding these backyards in the event of a significant rainfall event. The existing pipe alignment was modified to avoid removal of the large trees. The additional work was charged at unit rates consistent with the rates in the original bid. Change Order Number 2 was issued for \$49,786.40. The following is summary of the cost of this project.



As the total cost now exceeds \$50,000, the purchase order is presented to Council for ratification.

Staff respectfully requests Council's ratification of the purchase orders for the Bend Creek Road Pipe Replacement project.
