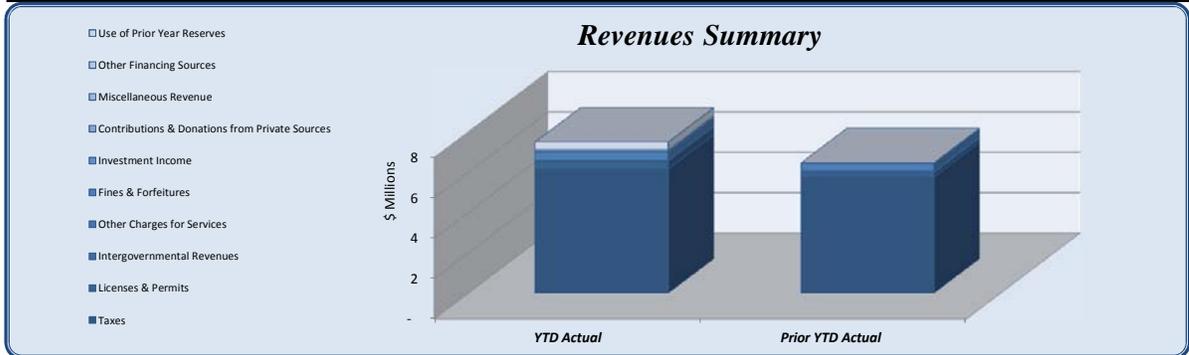
Following are the financial highlights for fiscal year 2012 through April 30, 2012. With few deviations, the year is progressing as planned. Almost all expenditures are on pace with expectations, and only a few revenues are off from expectations either positively or negatively. Though when all added, expenditures are well under budget. The franchise fee received from Georgia Power in February was just under \$2.8 million, exceeding the budget and last year. Permits pulled in April account for a large (positive) variance this month. April say revenues in this line item double the amount from the first three months due to the Von Maur renovations at Perimeter Mall. Court revenues were significantly above last year; mainly due to the milder winter. Overall, I continue to be cautiously optimistic on revenues this year especially now with property taxes and occupation taxes showing well so far. We'll know more mid-year once the HOST calculation and the tax digest are released.

No surprises on expenses either. The large positive variance in the police budget is mainly a timing issue with the 2012 merit increases not taking place until this month.

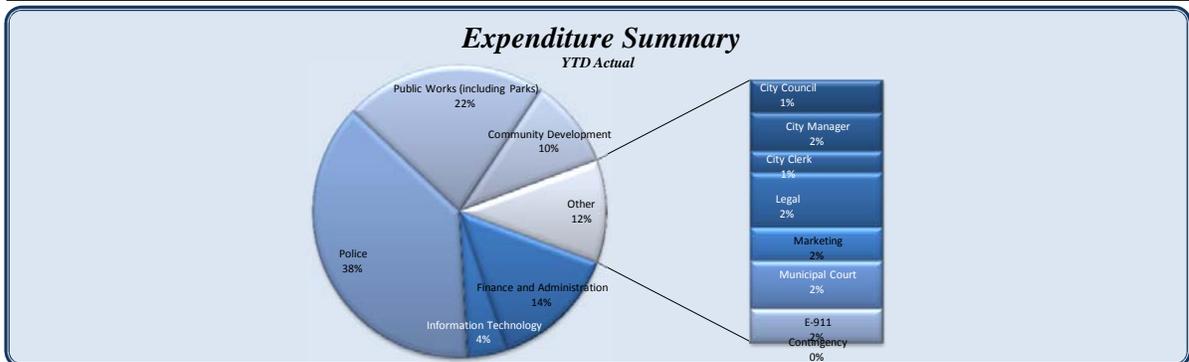
