Subject: Discussion of 2013 Paving Contract

ITEM DESCRIPTION

Approval of 2013 Paving Contract with Blount Construction

BACKGROUND

At its March meeting, the attached list of streets was recommended for paving in 2013. Two bids were advertised for resurfacing these streets. The first bid (ITB 12-02) was for full depth reclamation and paving and the second (ITB 12-03) was for patching and paving. The patching and paving bid also included crack sealing on Happy Hollow Road as a preventative maintenance measure. Based on an evaluation of the existing pavement and analysis of the bid prices, the final recommended strategy for each street is also provided in the attached list.

COMPLETE STREETS ANALYSIS

In accordance with the City's Complete Streets Policy, the major thoroughfares listed below have been evaluated for a retrofit of bicycle facilities as part of the repaving project. The City's Comprehensive Transportation Plan recommends bicycle facilities (i.e. bike lanes) for Spalding Drive and signed bicycle routes for North Peachtree Road, Dunwoody Park, Vermack Road, Peachford Road and Meadow Lane Road. Recently the Commuter Trails study completed for the Perimeter Center Improvement Districts (PCIDs) also recommended a road diet on Perimeter Center Place and bike lanes on Crown Pointe Parkway. The following table summarizes the recommended accommodations for each road as part of this paving project:

Road	Recommendation
Spalding Drive	Maintain existing-additional pavement and right of way would be needed for bike lanes
North Peachtree Road	Adjust striping north of Dunwoody Crossing to allow for connection of existing bike lanes at Brookhurst. Maintain existing striping south of Dunwoody Crossing
Dunwoody Park	Existing pavement curb to curb width is too narrow-use signs and shared lane symbols
Vermack Road	Stripe to provide bike lane from Vermack Court to Parliament Way.
	Existing curb to curb width from Parliament Way to Parliament Drive is too narrow for lanes, use signs and shared lane symbols

The City received six bids for both ITB 13-02 and ITB 13-03 and Blount Construction Company, Inc. was the low bidder with bids of \$214,767.1 and \$1,692,573.80, respectively.

FUNDING

The City has approximately \$2,200,000 available for this contract after considering all other cost associated with paving such as testing and inspection services. Based on the bid unit prices, the total cost of the paving including contingency for unforeseen conditions is estimated to be approximately \$2,050,000 leaving a fund balance of approximately \$150,000. At its April 8th meeting, the Mayor and Council expressed a desire to allocate any remaining balance at the end of the contract to paving additional residential streets. A list of recommended streets to be added as the budget allows is included as an attachment.

RECOMMENDATION

Staff respectfully requests that Council: (1) award a unit price contract to Blount Construction, (2) authorize staff to provide funding for the contract up to \$2,200,000; and (3) authorize the City Manager to execute the necessary documents following satisfactory review by legal counsel.
