**A RESOLUTION TO APPOINT MEMBERS OF THE ALCOHOL LICENSE REVIEW BOARD
FOR THE CITY OF DUNWOODY, GEORGIA**

- WHEREAS,** the City of Dunwoody is authorized by the City Charter to create boards, commissions and authorities as the Mayor and City Council deem necessary; and
- WHEREAS,** the Mayor and City Council previously adopted Chapter 2 ("Administration") of the City Code of Ordinances which calls for the creation of the Alcohol License Review Board; and
- WHEREAS,** Resolution 2009-06-38 created the Alcohol License Review Board for the City of Dunwoody, GA. with five members; and
- WHEREAS,** Resolution 2009-06-38 established terms for each member of the Alcohol License Review Board; and
- WHEREAS,** the initial term of office for board members Sally Horan, Brian Sims, and Steve Zisser expires on June 22, 2013; and
- WHEREAS,** the Mayor of the City of Dunwoody is authorized with confirmation from the City Council to appoint the following three (3) persons to the Alcohol License Review Board for the City of Dunwoody, and to add the following terms of office for each member:

Michael Bryan, 4 year termexpiring June 22, 2017
Brian Sims, 4 year term.....expiring June 22, 2017
Steve Zisser, 4 year termexpiring June 22, 2017

WHEREAS, this Resolution shall become effective upon its adoption.

NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the City of Dunwoody while in regular session on December 9, 2013 at 7:00 p.m. that these persons are appointed as members of the Alcohol License Review Board for the designated term.
