#### **CITY CLERK**

### Mid-Year Highlights

- In early 2015, the City Clerk coordinated with the City Manager to update and improve the agenda format for City Council meetings.
- Hiring is underway to fill the recently vacated Assistant to the City Clerk position.
- \* With the municipal election approaching, the City Clerk's office will manage the qualifying process and other election related functions in the coming months.

#### **COMMUNITY DEVELOPMENT**

### Mid-Year Highlights

- \* The Peachtree Corners-Dunwoody Winters Chapel Road Area Study was completed and adopted in April.
- A draft of the Perimeter Center zoning code and overlay has been prepared by the consultant team and submitted to the City for review. This follows several months of public outreach, sounding board meetings, and discussion with staff. A City Council work session was held on August 3 to discuss the draft, and adoption is anticipated in early 2016.
- This spring and summer, a series of public outreach efforts have been made to engage residents and other stakeholders in the five-year update of the Dunwoody Comprehensive Plan. The Consultant Team has prepared a draft of the plan, which is expected to be transmitted to the Atlanta Regional Commission for review in August. The final plan document is scheduled to be adopted by the City Council in October.

#### **ECONOMIC DEVELOPMENT**

### Mid-Year Highlights

- Economic Development has successfully coordinated the partnership between the City, Chamber and CVB to publish the Atlanta Business Chronicle's Dunwoody Market Report for the past four years. The 2015 Report was published on April 17<sup>th</sup> and included 12 articles focused on Dunwoody's economy, housing and lifestyle.
- After an exhaustive search, IHG decided to re up and expand their lease at Ravinia 3. IHG is Dunwoody's second largest employer with over 1,300 employees. During the term of the lease, IHG will grow by over 415 positions.
- \* Mercedes-Benz USA is relocating their Headquarters from New Jersey to Metro Atlanta, more specifically to Dunwoody on a temporary basis before building a new home in Sandy Springs. Mercedes-Benz recently moved 800 employees into their newly renovated space at Sterling Pointe.

- \* Through June 2015, 465 employment applications were received, and the following positions were filled: one Police Service Representative, one Assistant City Manager, three Police Officers, and one Municipal Court Clerk.
- Departmental requests for the FY 2016 budget have been submitted, and the budget process is underway.
- Following a procurement process, contracts for provision of City services have been renewed with Clark Patterson Lee, Jacobs, Lowe Engineering, and InterDev. Severn Trent was selected to provide finance and administration services, beginning in 2016.

## Mid-Year Highlights

- \* Completed several initiatives, including: Netwrix auditing and compliance software installation for compliance with PCI, HIPPA, and PII standards; Genetec Security access and video recording solution, including City Hall, Brook Run Park, and Dunwoody Park; Annual IT Security Audit; and installation for AFIS system for Police Department for latent print distribution.
- Significant progress has been made on the CAD-to-CAD one-button transfer, and a "go live" date is scheduled for August 10.
- Maintained 99% system (server, VoIP, network) uptime, and 99% application uptime.

# Mid-Year Highlights

- \* Marketing/Public Relations staff demonstrated a commitment to responsiveness, responding to 100% of media inquiries within 24 hours.
- The City's Facebook following grew significantly from 1,983 followers in January 2015 to 2,825 at the end of June. In total, posts on the City's Facebook page received 159,040 shares, comments, and "likes".
- As of the end of June, the City has amassed nearly 4,000 Twitter followers, and City tweets were viewed over 120,000 times during the first half of 2015.
- In June, an informal meet and greet opportunity was hosted by District Two Council Members at Food Truck Thursday in Brook Run Park. A town hall meeting was held at the Dunwoody Nature Center in July, led by Council representatives for District One. District Three representatives will host a "Teen Town Hall" at Dunwoody High School later this summer.

## Mid-Year Highlights

- Improvements have been made to parks facilities throughout the City, including upgrading the front entrance and replacing the playground at the Dunwoody Nature Center, and relocating the Dog Park and demolition of the dormitories at Brook Run Park.
- In the Georgetown area, construction of the Park on Pernoshal Court and the Georgetown Connector Trail is well underway, with targeted completion in late-fall. Shade structures are being designed for the playground at Georgetown Park.
- \* The remodel of the Donaldson-Bannister Barn is in the design process.

#### **POLICE**

### Mid-Year Highlights

- On April 1, 2015, the Dunwoody Police Department was awarded State Certification through the Georgia Association of Chiefs of Police. The department was awarded State Certification after a rigorous examination of the department covering eight critical areas essential to effective law enforcement services covering 129 standards. Fewer than 20% of eligible law enforcement agencies in the State of Georgia are certified.
- As a tribute to National Police Week 2015, the Dunwoody Police Department contributed to The International Association of Chiefs of Police (IACP) campaign #WhylWearTheBadge highlighting why police officers serve their community. The result was this award-winning online video: <a href="https://www.youtube.com/watch?v=2DOSAjgKmYY">https://www.youtube.com/watch?v=2DOSAjgKmYY</a> The Telly Awards has named The Dunwoody Police Department as a Bronze winner in the 36th Annual Telly Awards for the video. With nearly 12,000 entries from all 50 states and numerous countries, this is truly an honor.
- The Dunwoody Police Department is a leader in law enforcement's use of social media to engage the community and demonstrate transparency. Earlier this year, the department's Facebook page reached 10,000 likes and the department earned 2nd place in the Golden Post Awards for Outstanding Social Media results.
- Average police response time to all calls was 351.5 seconds, and average police response time to Priority 1 calls was 263.7 seconds for the first half of 2015. These response times are well below target response times of 360 seconds or less and 300 seconds or less, respectively.

#### **PUBLIC WORKS**

# Mid-Year Highlights

- A number of pedestrian facility projects have been in progress throughout the year, including the completion of the Hensley Drive and Mount Vernon Way sidewalk. Sidewalk on Mount Vernon Road is currently under construction, and the Peachford Road sidewalk is expected to go to construction later this year. Crosswalks in the PCID area are currently being replaced, and additional crosswalk improvements are planned for construction this year at Dunwoody Elementary, Mount Vernon at Forest Springs, and Tilly Mill at Stonington.
- Several road improvements have been made since the beginning of 2015. Most notably, the Dunwoody Village Parkway project was wrapped up, with final project cost \$400,000 below budget. Upon completion of DeKalb County's water main replacement on Mount Vernon Road,



- the City is resurfacing the section between Ashford Dunwoody Road and Vernon Oaks Drive. In addition to these major improvements, the City's annual paving efforts are ongoing.
- \* Earlier this year, storm pipe lining was completed on Hidden Branches Drive. Future stormwater projects for 2015 include Martina Drive stream stabilization, culvert replacement on North Peachtree, and culvert lining on Delverton Drive.
- \* NPDES permit annual reporting is complete and has been submitted for the stormwater utility.
