Subject: YTD Financial Report for September 2015

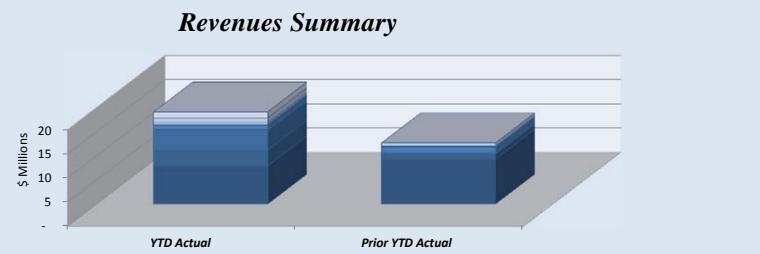
Following are the financial highlights for through September 30, 2015. Overall revenues are above budget led by building permits with the State Farm project. Hotel taxes are also strong this year with revenue coming in at a record high for July. On the negative side, occupation taxes (aka business licenses) continue to remain off last year's pace and will likely finish the year there. Also, with the tax digest in hand, I do not anticipate receiving the 5% increase budgeted for this line item. The digest rose just slightly. The negative year-to-date revenue also reflects the homestead freeze tax refunds. The difference from last year is large but is a timing issue only. Court revenues are 84% of year-to-date budget; gaining some from last month. E911 revenues are behind last year but most of that is a timing issue only. HOST is exceeding the budget.

Expenses are as expected. The budget overage in Community Development is due entirely to the increased building permit revenues. Also, showing is \$3.5 million of the DeKalb settlement that was earmarked for capital park projects. Those funds were transferred to the Capital Projects Fund; causing the budget overage in the General Fund. Later this month, a budget amendment will be presented to capture these items as well as other adjustments that are needed for the current year. The October report will reflect the budget amendment that was adopted last month.

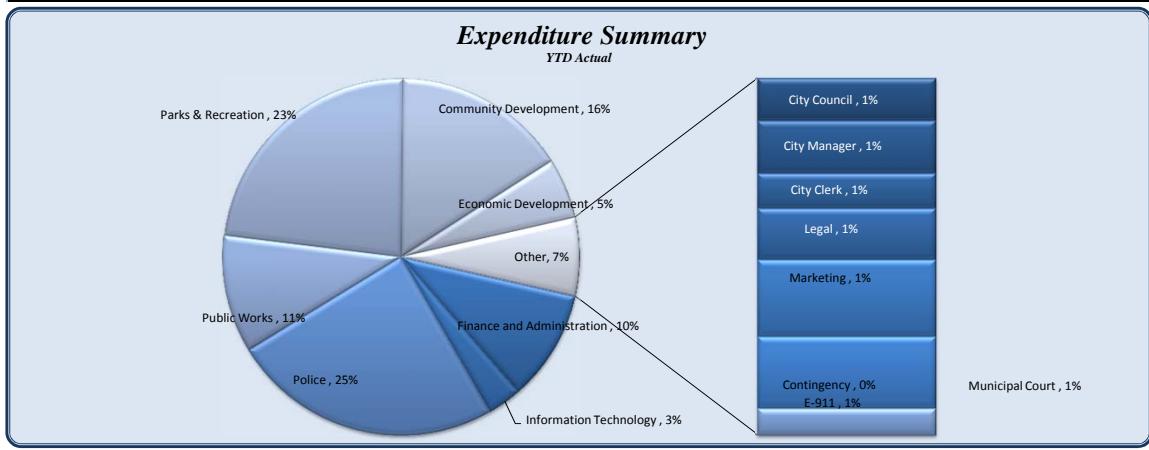

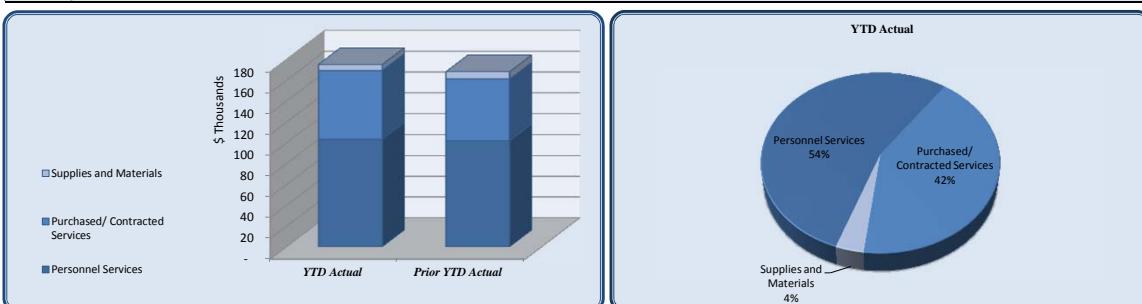

Section 2.07 of the Dunwoody Code of Ordinances states, "The mayor shall be provided an annual expense allowance of \$5,000.00 and each councilmember shall be provided an annual expense allowance of \$3,000.00 for the reimbursement of expenses actually and necessarily incurred by the mayor and councilmembers in carrying out their duties as elected officials of the city." The expenses highlighted below are those credited to that allowance and totaled separately. Expenses not highlighted are other expenses attributable to the City Council Department budget.
