Subject: Media Production and Photography Permit Fees

ITEM DESCRIPTION

A resolution to adopt fees for Media Production and Photography Permits

BACKGROUND

On April 23, 2012, the City Council adopted fees for Filming Permits by resolution. The proposed resolution for Media Production and Photography Permit Fees modifies the language for the permits to reflect the revisions to the Film and Video Policy, specifically renaming "Filming Permit" to "Media Production Permit;" however, the fees remain the same. As proposed, additional fees have been incorporated for "Photography Permit, Annual" and "Photography Permit, One-Day." This is also in line with the changes to the policy, which now provides reduced permit for photography shoots on public property which do not exceed two hours in duration or ten minutes of set-up/teardown time.

RECOMMENDED ACTION

Consider and approve the proposed resolution adopting Media Production and Photography Permit fees.

A RESOLUTION ADOPTING AND APPROVING MEDIA PRODUCTION AND PHOTOGRAPHY PERMIT FEES

- **WHEREAS,** the Charter of the City of Dunwoody authorizes the City to provide for the general health, safety and welfare of the citizens of the City;
- **WHEREAS,** the City of Dunwoody's Media Production and Photography Policy aims to deter and limit unregulated commercial film production, photography, and similar activities from occurring within the City that would cause a public nuisance and pose a threat to public health, safety, and welfare; and
- **WHEREAS,** pursuant to the Media Production and Photography Policy, the City Council desires to adopt the following fees for the time, expense, and limitations on the public use of property or facilities that media productions and photography may cause.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and City Council of the City of Dunwoody, while in session on September 15, 2015, that the following permit fees are hereby adopted:

- a) Media Production or Photography Permit Application Fee: \$25
- b) Media Production Permit Daily Fee: \$100
- c) Park Facility or City Facility Daily Rental Fee: \$500
- d) Off-Duty Police Officers Hourly Fee: \$55/per officer with a minimum of three hours per officer
- e) Photography Permit, Annual: \$100
- f) Photography Permit, One-Day: \$50
