Subject: Award of a Contract with Baldwin Paving for Asphalt Resurfacing (Michael Smith)

ITEM DESCRIPTION

Award of a contract with Baldwin Paving for asphalt resurfacing of streets in the five year paving plan.

BACKGROUND

At the December 2015 council meeting, the attached list of streets was recommended for paving in 2016. All of these streets with the exception of Valley View Road were included in the basic scope for the invitation to bid (ITB 16-02). Valley View was moved to the supplemental paving list because staff was uncertain of the county's timeline for replacing the water line on this street. In total the scope included over 16 lane miles of paving on 32 roads (List Attached).

The city has received three bids with Baldwin Paving submitting the lowest bid at \$2,455,276.22 (Bid Results Attached). In past years the city has typically received at least five paving bids and this year's unit prices for asphalt items are to ten to thirty percent higher than last year. This unusually large cost increase can be attributed to high demand for contractor labor due to increased construction activity.

FUNDING

The total cost for paving, construction management and inspection is anticipated to be approximately \$2,900,000 including a 10% contingency. The total funding available is approximately \$2,935,000 including a \$175,000 contribution from Sandy Springs for Dunwoody Club Drive.

A portion of the contingency will be needed to put the final topping on some streets in the Dunwoody Green development that have all of the houses completed. Valley View Road and the other supplemental streets on the paving list could be added to this contract later this year if additional funding becomes available.

RECOMMENDED ACTION

Staff recommends award of a unit price contract for asphalt resurfacing to Baldwin Paving Company, Inc. in the amount of \$2,700,000 including a 10% contingency.
