Subject: **Approval of On-Call Contracts for Stormwater Easement Acquisition Services**

ITEM DESCRIPTION

Approval of contract with Sustainable Water Planning and Engineering, LLC for storm water easement acquisition services on an as needed basis.

BACKGROUND

The majority of storm water rehabilitation and replacement projects involve infrastructure that was installed prior to the establishment of the City and Storm Water Utility. As such, current easements involving this infrastructure predate Dunwoody and were generated by agreement between private property owners and DeKalb County. Upon the City's incorporation, the right-of-ways transferred to the City, but any easements granted specifically to DeKalb County remained with DeKalb. Therefore, in order to perform maintenance and capital improvements that the City desires to perform on private property, the City needs particular temporary and permanent easements from homeowners. The purpose of this contract is to seek assistance in easement acquisition to gain access to properties for programmed storm water repairs. These services will involve the acquisition of both permanent maintenance and temporary construction easements.

Contracts for Stormwater Easement Acquisition Services were previously awarded in March of 2015, and expired on March 31, 2017. This contract will replace the previous contracts for the same services.

RECOMMENDED ACTION

Staff recommends award of a contract for easement acquisition services to Sustainable Water Planning and Engineering, LLC.
