**A RESOLUTION TO APPOINT MEMBER OF THE DUNWOODY VOLUNTEER

WHEREAS, the City of Dunwoody is authorized by the City Charter to create boards, commissions and authorities as the Mayor and City Council deem necessary; and

WHEREAS, Resolution 2011-04-24 formalized the Dunwoody Volunteer Coordinating Committee for the City of Dunwoody, Georgia; and

WHEREAS, Resolution 2016-03-07 revised the membership of the Volunteer Coordinating Committee to add two ex-officio members who are high school students who are residents of the City of Dunwoody at the time of appointment and for the duration of the term to serve a 2-year term, and two ex-officio members who are college students who are residents of the City of Dunwoody at the time of appointment and for the duration of the term to serve a 2-year term; and

WHEREAS, the Mayor of the City of Dunwoody is authorized with confirmation from the City Council to appoint Sam Lucius as one of two high school students to be appointed as a members of the Volunteer Coordinating Committee for the City of Dunwoody with the following term of office:
