Subject: Construction Funding Authorization for the Peachtree

**Industrial Blvd Access Road Sidewalks** 

#### ITEM DESCRIPTION

Request to accept Multimodal Safety and Access Grant (MMSAG) and authorize funding for grading, drainage and sidewalk improvements on Peachtree Industrial Boulevard southbound access road utilizing the previously approved unit price contract with Georgia Development Partners.

### **BACKGROUND**

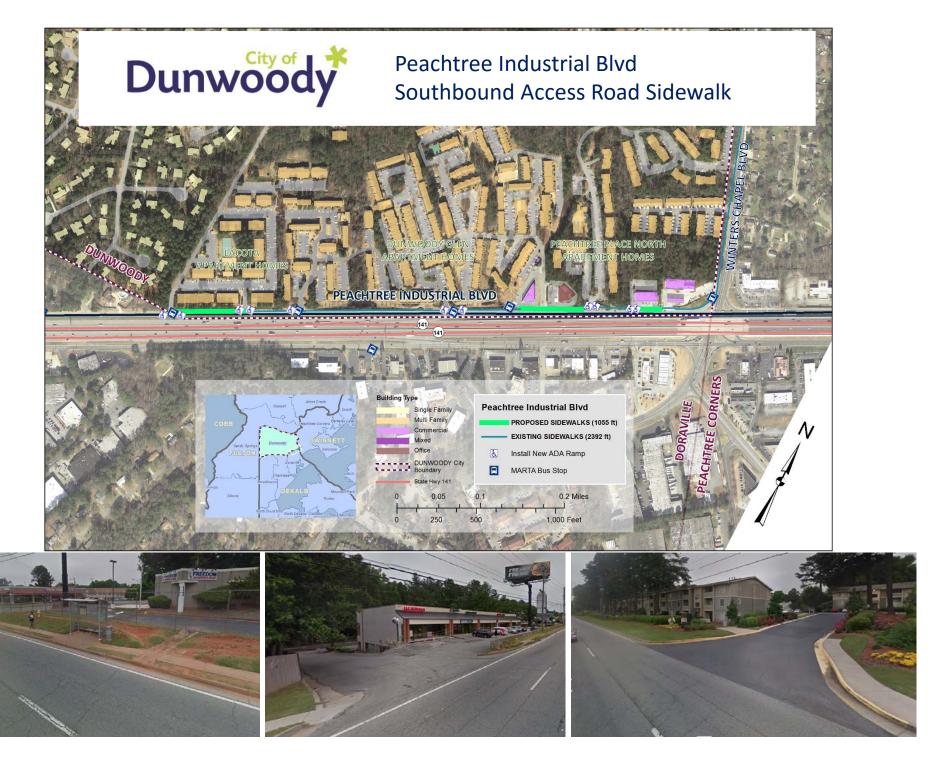
In April 2017 the City of Dunwoody was awarded a Multimodal Safety and Access Grant (MMSAG) by the Georgia Department of Transportation (GDOT) for the construction of sidewalks on the Peachtree Industrial Blvd southbound access road between the southern city limits and Winters Chapel Road. This project will eliminate nearly 1,100 ft of existing sidewalk gaps and provide 11 new ADA accessible curb ramps.

This project has been identified in the City of Dunwoody's Sidewalk Priority List and has scored high based on the demonstrated demand and access to transit and adjacent land use. By completing these sidewalk gaps and providing the recommended upgrades to the ADA ramps, this area will become more accessible to a broader group of users. These improvements will also complement existing transit service, further improving the connectivity for these residents to employers, educators, and local retail centers.

GDOT has committed up to \$101,500 or 70% of the final project cost through this grant, whichever is less. Georgia Development Partners has submitted a construction cost estimate. Based on anticipated construction management and contingency costs, the total cost to construct this project is estimated be \$150,000. The matching funds are not currently allocated within the city's revolving sidewalk fund. Therefore staff requests that these funds be allocated in a future budget amendment.

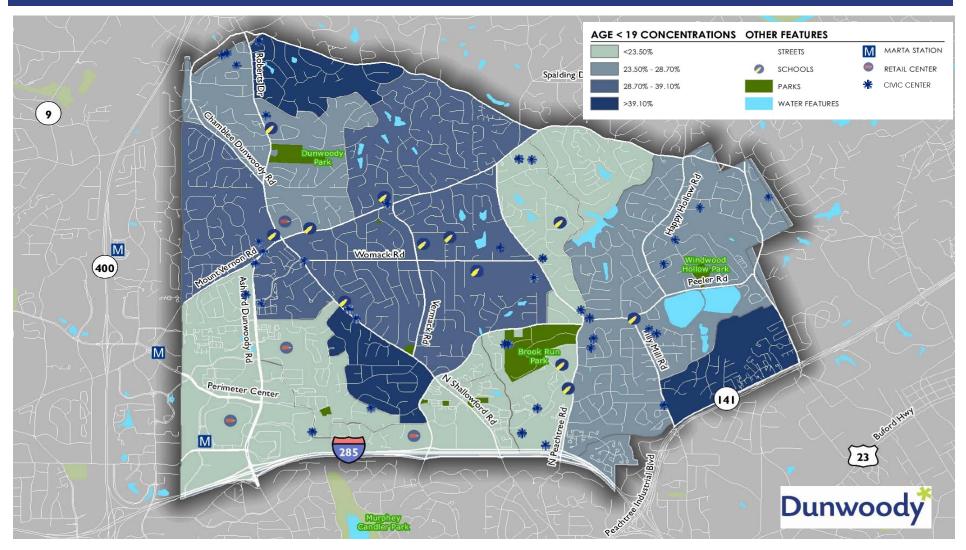
### **RECOMMENDED ACTION**

Staff requests funding authorization through the existing Georgia Development Partners unit price contract to construct the sidewalk gaps on the southbound access road of Peachtree Industrial Blvd and to approve up to \$50,000 of matching funds. If approved, it is anticipated that Georgia Development Partners will begin construction on this project later this year.

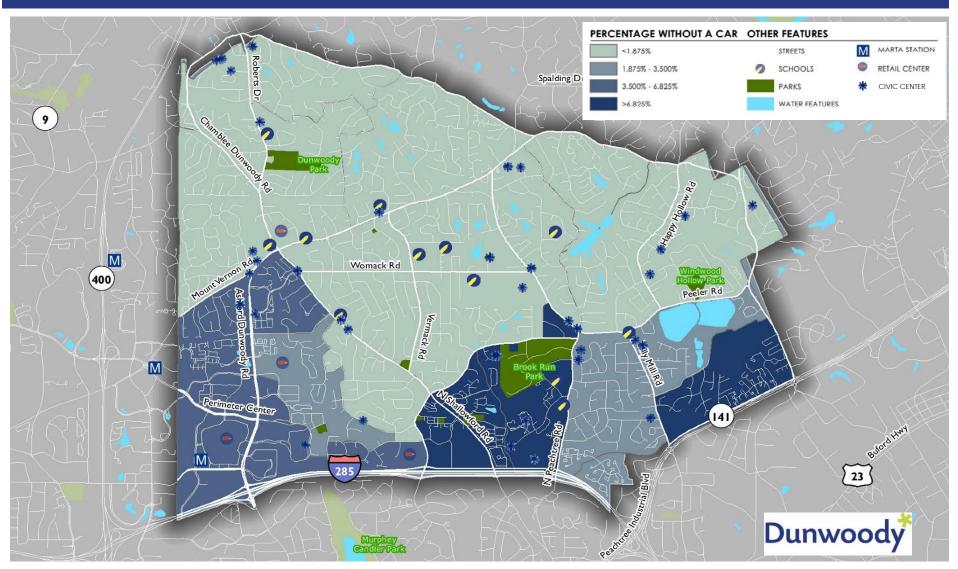


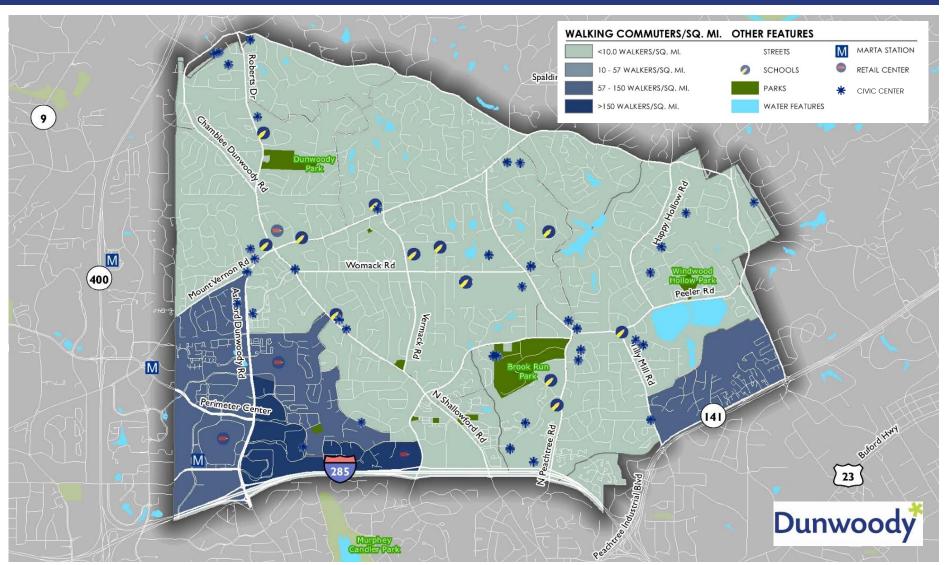

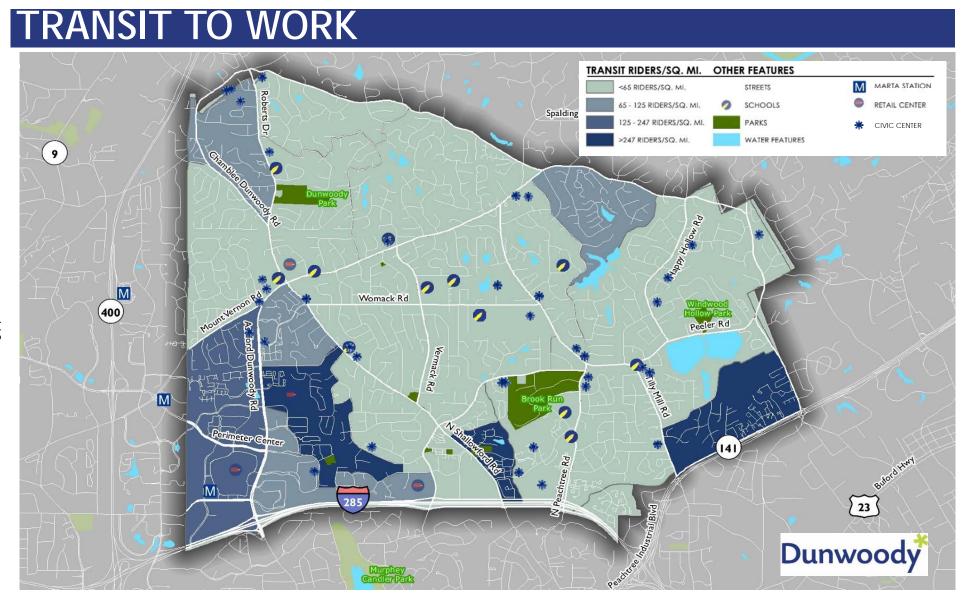
