This Grand Jury, sworn in by the **Honorable Gregory A. Adams** in the DeKalb Superior
Court on **May 3, 2016** respectfully submits the following presentments.

INDICTMENTS

This Grand Jury was presented with (303) cases during the May-June 2016 term. Of these cases (299) True Bills and (4) No Bills were returned. An additional (183) cases proceeded by Accusation.

REQUEST FOR PUBLICATION

Pursuant to the O.C.G.A. § 15-12-80, we the presently constituted Grand Jury recommend to the **Honorable Gail C. Flake** that these general presentments be published in whole in the County Legal Organ.

General Recommendations:

- Attach a FAQ document to the Grand Jury Summons to answer basic questions such as what the difference is between a Grand Jury Summons and a regular Jury Summons.
- Add a large map of DeKalb County to the wall for the ADA, witnesses, and jury reference.
- Fix the light in the Grand Jurors' break room so those in the room can CLEARLY see when the Grand Jurors are deliberating or not.
- Replace the microphone and/or have a good supply of batteries available in the Grand Jury room at all times.
- Review probable cause and the distinction between probable cause and reasonable doubt at the beginning of the first **few** days of the session.
- Provide training and examples about the most common felonies that the Grand Jury
 will be exposed to during the term. The guns and drugs presentation, while
 interesting, was too long and detailed. Also, ADA's and witnesses should learn to
 pronounce drug names or use acceptable generic terms or acronyms.

Inspection of Department of Finance and Office of Planning and Budget June 28, 2016

Four administrators from the Department of Finance and Office of Planning and Budget, led by Mr. Jon Jay Vinicki, Director of the Office of Management and Budget, gave a presentation to the Grand Jury members, which included the following general topics.

- (1) Structure of the finance department and budget office
- (2) Functions, duties, and responsibilities of these offices
- (3) Difference between government finance and "checkbook" finances
- (4) Controls, restrictions, and oversight
- (5) Annual budget process and taxation
- (6) DeKalb County's population, operating budget, outstanding debt, number of employees, number of retirees, and invoices processed annually
- (7) How fund accounting works
- (8) Budget process timeline
- (9) Financial oversight

Grand Jurors' questions focused on the following areas:

- (1) The auditing process
- (2) The retiree program
- (3) The P (purchasing) card program and its current restrictions
- (4) County debt
- (5) The incorporation of cities within unincorporated DeKalb County and how that affects the overall allocation of money for county versus city functions
- (6) Who constitutional officers, such as the DeKalb County sheriff, are accountable to
- (7) The extent of independence of the external auditors

DeKalb County Sheriff's Office Inspection:

On June 23, 2016, the May-June, 2016 Session of the DeKalb County Grand Jury interviewed Sheriff Jeffrey Mann, representing the DeKalb County Sheriff's Office. Outlined below are some of Sheriff Mann's responses to Grand Jurors' questions.

Sheriff Mann explained that in most of the 159 counties of the state of Georgia, the sheriff's office constitutes the chief law enforcement entity of the county. In larger, more populous counties, such as DeKalb County, there is a separate county police force. In DeKalb County, the Sheriff's Office performs three important functions: (1) management of the county jail,

(2) serving criminal warrants, and (3) security of the DeKalb County courthouse. The DeKalb County Jail can house up to 3900 inmates, but the current population is about 2000. The Sheriff's office has about 860 employees, 500 of whom are assigned to the jail. Sheriff Mann explained that the biggest challenge he has is related to staffing, recruiting, and retaining employees. Deputies, especially those who work at the jail, must be mature, patient, and restrained. The minimum age requirement is 21 years old. Sheriff Mann has asked the DeKalb County Board of Commissioners to raise the current pay for deputies to the market rate to help with staffing issues.

The Grand Jury's concerns were primarily with the management of the jail. Previous cases heard by the Grand Jury during the current session raised some concerns about the presence of cell phones and illegal possession of drugs by inmates of the county jail. Sheriff Mann explained that there are three possible avenues for cell phones and other illegal contraband, including drugs, to enter the jail. These are (1) by arrestees due to failure by deputies to properly check or pat them down; (2) by visitors; and (3) by vendors (such as food service providers, medical and dental providers, and maintenance workers). Sheriff Mann explained that several procedures were in place to mitigate the presence of cell phones and drugs in the jail.

- (1) All visitors must pass through a magnetometer.
- (2) All visitors, except clergy and attorneys, must visit inmates through a remote video conferencing system.
- (3) Visiting clergy and attorneys are separated by a glass partition from inmates.
- (4) Two canines are assigned to duty in the jail. One dog is specifically trained to detect lithium in lithium cell phone batteries. The other dog is specifically trained to detect illegal drugs.

Sheriff Mann maintained that only one inmate had been caught with a cell phone in the past two years. He estimated approximately a dozen people had brought in drugs in the past 15 years (the time during which Sheriff Mann has been associated with the jail).

Grand Jurors also questioned Sheriff Mann about an incident in which a rap video performed by orange suited inmates at the jail had been posted to You Tube. Sheriff Mann indicated that although inmates who participated in the video were disciplined, he stated that the video was a consequence of high spirits. An inmate's visitor who had filmed the feed of a video visitation with her cell phone posted the video to You Tube.

With respect to a Grand Juror's question concerning inmates who may possibly have mental illness, Sheriff Mann explained that any inmate suspected of having such problems are screened upon intake to the jail. There are sections of the jail designated for housing inmates with severe mental illness, those needing suicide watch, and others who may need a transitional space due to more moderate mental issues.

DeKalb County, GA, Grand Jury (May-June, 2016) Inspection of the Investigation of Theft at the DeKalb County Department of Watershed Management

The Grand Jury heard a case during the current term regarding charges of theft by a Watershed employee. The indictment charged the employee with selling metal owned by the Watershed Department to a local recycling center. The defendant's statement was that his supervisor provided the metal and the terms for selling it. The ADA explained to us that the supervisor was not charged since his name was not on the receipt. It was the Grand Jury's concern that if a supervisor was involved in this particular case and was not indicted there could be a larger ongoing issue of employee theft. On June 23, 2016, the Grand Jury spoke to the Director of Watershed Management, Mr. Scott Towler, and the Superintendent of Maintenance and Construction, Mr. Alan Moore, who were extremely helpful in answering our questions. They indicated that theft was a continual problem at Watershed Management due in part to a large number of employees combined with low wages but that recent measures have been taken to resolve the issue. We noted the following responses:

- There is video surveillance but it is not monitored.
- Recently Mr. Moore identified 23 employees as having sold metal to a local recycling center. Four employees were terminated, and others were disciplined.
- The chain link fence is routinely breached using bolt cutters.

- · The supervisor was questioned but denied any involvement.
- Security at the Department of Watershed is provided by a vendor company.

The Watershed Department reported \$226,826.15 total loss for a two year period. Because of the amount of money lost in this period, we recommend a more thorough non-criminal investigation with a view toward answering the following questions.

- Would investing more money in a better fence or alarm system be offset by the savings?
- Can fewer people be provided access to valuable equipment to reduce risk?
- Are there other security companies that can provide better results?
- What is the most common example of theft and can that particular scenario be solved?
- Has theft decreased since the new security measures were put in place?

On June 7, 2016 the DeKalb County Board of Equalization presented names of qualified citizens of DeKalb County to serve as members and/or alternate members of the Board of Equalization for a three year term beginning January 1, 2017. We, the Grand Jury members approved the selected members. (See attached) The original document is filed in the DeKalb County Superior Court Clerk's Office.
