Subject: Approval of a Contract Amendment with Blount Construction to

Resurface Additional Roads in 2018

ITEM DESCRIPTION

BACKGROUND

In March the City Council approved a contract with Blount Construction in the amount of \$2,926,609 to resurface 29 roads in 2018. Paving began at the end of April and about 1/3 of the paving has been completed. Based on the progress to date the city is in a position to add additional paving to this year's plan using the 2017 paving budget surplus and other 2017 surplus funds reallocated to paving by the Mayor and Council. The following streets are recommended for paving using the estimated surplus of \$500,000:

Valley View Road Valley View Court Manhasset Court

Valley View Road (deferred for several years for a DeKalb County water main replacement) and Manhasset Court are currently on the 2019 paving list. Valley View Court, a cul de sac off of Valley View Road, it is not currently on the paving list based on the 2013 pavement assessment which rated the street in fair condition. However the county's water main replacement for Valley View Road extended to Valley View Court and portions of both roads have been patched where the new line extended under the roadway. This utility construction work, the further aging of the pavement since the last rating and the proximity to the proposed paving on Valley View Road are all factors in the recommendation to add Valley View Court to the paving list.

The original contract approval also includes a 10% contingency of \$293,000. If adequate contingency funds remain unspent they could be used to pave additional streets from the 2019 list beginning with Manhasset Cove, Hathburn Court, Manhasset Drive, Trumbull Drive, and Trumbull Court.


RECOMMENDED ACTION

Staff recommends approval of a contract amendment to increase Blount's contract amount from \$2,926,609 to \$3,340,000 plus a 10% contingency to pave additional streets in 2018.
