- WHEREAS, the City of Dunwoody owns that certain property located at 5339 Chamblee Dunwoody Road, known as the North DeKalb Cultural Art(S) Center (hereinafter the "Arts Center") as set forth on the survey attached hereto as Exhibit "A" (hereinafter the "Property"); and

- WHEREAS, the City of Dunwoody has entered into Facilities Use Agreements for portions of the remainder of the Arts Center with the Stage Door Players and the Chattahoochee Handweavers Guild (hereafter the "Arts Users") as set forth on the illustrations attached hereto as Exhibit "C" and "D"; and
- **WHEREAS,** the City of Dunwoody has authorized the assignment of the Facilities Use Agreements with the Arts Users to the Facilities Authority; and

NOW THEREFORE BE IT RESOLVED by the Facilities Authority as follows:

- 1. The Facilities Authority hereby accepts the transfer of the Property (less and except the Library Area); and
- 2. The Facilities Authority authorizes the acceptance of the assignment of the Facilities Use Agreements with the Arts Users.



Spruill Center for the Arts



