On 3/13/2023 Officer W. Smith and I participated in a Georgia Department of Revenue (DOR) "underage alcohol" detail in the City of Dunwoody. At approximately 12:00PM I responded to 4725 Ashford Dunwoody Rd Rd (Walmart) in reference to a minor purchasing alcohol.
