Council Member Heneghan led the invocation.

Administration of Oath of Office to Officer David Perkins (Mayor Deutsch)

Mayor Deutsch said the oath of office will not be administered today.

Gary Sonnier commented on the commperehensive plan. He is concerned about the possibility of too much density in the northern part of Dunwoody.

Bob Hickey commented on the year end audited financial statements.

Dave Cohen commented on the size of the comprehensive plan and the effect it might have on traffic flow.

Juan Lago spoke on the comprehensive plan and the purpose of the plan.

Wendi Taylor commented on the comprehensive plan and the potential impacts the plan could have on Dunwoody residents.

Tom Taylor commented on the comprehensive plan and finished Mrs. Taylor's comments.

Scott Richmond commented on the solar discussion item and his support of this item.

Ali Mahbod commented on the cost of the proposed building lighting and Christmas lighting items on the agenda.

Bradley Handznk commented on the solar discussion item and said he supports the idea of the city adopting solar panels.

Meredy Shortal shared an idea for the life south building to be converted into a pocket park.

Mayor Deutsch recognized Sarv Dharavane, the 3rd Place winner in the Scripps National Spelling Bee, and presented him with a plaque.

3. Presentation of FY2024 Audit Results (No Action)

Richard Platto introduced Josh Carroll of Mauldin & Jenkins.

Mr. Carroll presented an overview of the FY2024 audit results, noting that Mauldin & Jenkins issued a clean opinion.

PUBLIC HEARINGS

<u>Consent to Transmit Draft 2025-2045 Comprehensive Plan to the ARC and the Georgia Department of Community Affairs for Review (Allison Stewart-Harris & Richard McLeod)</u>

Richard McLeod said this is the first public hearing for the Comprehensive Plan and the hearing is for approval to transmit the plan to the Atlanta Regional Commission and the Georgia Department of Community Affairs for review. Mr. McLeod introduced Allison Stewart-Harris to present the draft of the Comprehensive Pan.

Ms. Stewart-Harris presented the draft 2025-2045 Comprehensive Plan. She said the draft plan is a high-level look at the growth and development of the city. The plan focuses on the neighborhoods and future land use approaches. She said the Community Work Program for the next five years is required in this Plan. Ms. Stewart-Harris said the deadline for adoption of the Plan is October 31.

Mayor Deutsch opened the Public Hearing without objection.

Dan Weber said he communicated with the community and generated a petition against the Plan. He provided a handout and visual map for the City Council.

Robert Wittenstein spoke against the Plan.

Judy Miller commented on multi-use dwellings and said there needs to be more details.

Mayor Deutsch extended the public comment time for three additional minutes.

Dennis Shortal commented that multi-units are not appropriate in the areas marked yellow in the Plan.

Bridget ?? said she echoes what everyone else is saying and asked Council to listen to the community, not the developers.

Mayor Deutsch granted two additional minutes for public comment.

Juan ?? spoke against high rises and apartments.

V. Jackson expressed concern about the traffic and noise.

Mayor Deutch said the time is also extended for anyone wishing to speak in favor.

Colin May said he is in favor of the Plan and the growth it will bring.

Mayor Deutsch closed the public hearing without objection.

Council Member Price motioned to transmit the draft 2025-2025 Comprehensive Plan to the Atlanta Regional Commission and the Georgia Department of Community Affairs for review. Council Member Lambert seconded.

Council Member Heneghan amended his motion to pull and strike North Peachtree Road from page 80 with all regards to the neighborhood transition opportunities. Mayor Deutsch seconded.

Council Member Price offered an amendment that in the Perimeter core use area that multi-unit senior assisted living, mixed-use, and regional commercial all be yellow use and to adjust the language that discusses the MARTA TOD to say we will work with PCID and MARTA for redevelopment of that property but not reference a specific plan. Council Member Heneghan seconded.

brief presentation on solar benefits and presented different models for installing solar. He gave an overview of the GA Bright program and options to pay for solar. He asked Council to consider applying for the GA Bright program or consider the option to purchase or lease solar.

10. <u>Dunwoody City Hall Facade Lighting (Rachel Waldron) (No Action)</u>

Rachel Waldron presented a contract with Greenspeed to add permanent façade lighting to three sides of the roofline at City Hall. The contract is in the amount of \$96,156.38.

Following discussion, Mayor Deutsch suggested looking into something different for lighting City Hall.

11. FY2025 Mid-Year Budget Amendment (Richard Platto) (No Action)

Richard Platto presented the FY2025 mid-year budget amendment. He said the adopted General Fund budget revenue will increase \$1.3, with no change to the operating expense budget within the General Fund Mr. Platto said these changes mean that the adopted budgeted use of fund balance of \$1,262,213 will be eliminated for FY2025.
