A RESOLUTION TO RETURN TO THE PLANNING COMMISSION THE TEXT AMENDMENT TO AMEND CHAPTER 27 (ZONING ORDINANCE) OF THE CITY OF DUNWOODY CODE OF ORDINANCES; TO DEFINE COMMUNITY RESIDENCES AND RECOVERY COMMUNITIES AND CREATE USE REGULATIONS FOR SUCH USES

- WHEREAS, the Mayor and City Council of the City of Dunwoody ("City Council") are charged with the protection of the public health, safety, and welfare of citizens of the City of Dunwoody ("City"); and
- **WHEREAS**, the City Council has adopted a moratorium on drug rehabilitation centers and other facilities that treat drug and alcohol dependency; and
- WHEREAS the staff has been instructed to draft and propose new regulations for such uses; and
- WHEREAS, a draft of a text amendment to define community residences and recovery communities and create use regulations for such uses was reviewed by the City Planning Commission on December 12, 2023; and
- WHEREAS, the City Council wishes for the City Planning Commission to conduct additional deliberation and review of public comment; and
- WHEREAS, after review, the Mayor and Council have determined that it is in the best interest of the City to return said text amendment to the Planning Commission for an additional public hearing.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF DUNWOODY, GEORGIA:

- Section 1. The Planning Commission shall conduct another public hearing for the proposed text amendment to define community residences and recovery communities and create use regulations for such uses and issue a recommendation.
- **Section 2.** After completion of the Planning Commission review, the text amendment shall be returned to the City Council for review and consideration.
