Subject: **Supplemental Agreement with the Georgia Department of Transportation for the Village Crossing Project**

ACTION

Authorize the Mayor, City Manager, or designee to execute a supplemental agreement to the project framework agreement with the Georgia Department of Transportation to receive additional federal funding for design of the Village Crossing.

SUMMARY

The original Project Framework Agreement (PFA) was executed on September 27, 2024. It included a preliminary design budget of \$500,000, comprising \$250,000 in federal funding and \$250,000 in local funding. The city has secured an additional federal grant of \$600,000 from the Surface Transportation Block Grant (STBG) Program to complete design, with a required minimum local funding contribution of \$150,000. The federal funding is managed by the Georgia Department of Transportation (GDOT) and requires approval and execution of a supplemental agreement to the PFA.

DETAILS

The 2011 Dunwoody Village Master Plan identified the Village Crossing project to construct sidewalks, cycle track, landscaped buffers, pedestrian crossing enhancements, and improved lighting.

Council Approved Design Contract – July 2024
Public Information Open House – Winter 2026
Right of Way Acquisition – Fall 2026
Construction – Winter 2029

RECOMMENDED ACTION

Authorize the Mayor, City Manager, or designee to execute a supplemental agreement with the Georgia Department of Transportation to receive federal funding for design of the Village Crossing project.
