Action

Acceptance of a donation from the Estate of Dr. Betty Wills in the amount of \$10,000 to be used for the purchase, installation and maintenance of American Flags in all parks in the City of Dunwoody.

Details

Dr. Betty Wills was known to the Parks Department as the "Flag Lady" due to her community work of placing American flags in each Dunwoody park. A flag in Georgetown Park was dedicated in her honor in 2014, as well as a park bench in Brook Run Park.

Recommendation

Staff respectfully requests that Council: (1) accept a donation from the Estate of Dr. Betty Wills in the amount of \$10,000 to be used for the purchase, installation and maintenance of American Flags in all parks in the City of Dunwoody; (2) authorize the City Manager to execute the necessary documents.

It is my desire that Bret Walker, the current Parks and Recreation Manager, manage, direct and supervise the proper use of this gift on behalf of the City of Dunwoody. If the Parks and Recreation Department of the City of Dunwoody, Georgia no longer exists and has no successor in interest or its successor in interest cannot be identified with reasonable certainty, or if the beneficiary does not agree to use this gift in accordance with the terms set forth hereinabove, then this gift shall lapse, and the property subject to this gift instead shall be distributed i[n] accordance with the terms of Article FOURTH hereinbelow.

This acknowledgment is made solely for the purpose of confirming receipt of the above-described devise and confirming recipient's agreement to fully comply with the terms of the devise.
