Subject: **Supplemental Agreement No. 1 with the Georgia Department of Transportation for Phase 2 of the Winters Chapel Path**

ACTION

Authorize the Mayor, City Manager, or designee to execute a supplemental agreement with the Georgia Department of Transportation to receive additional federal funding for design of Phase 2 of the Winters Chapel Path project.

SUMMARY

In April 2025, City Council approved the Project Framework Agreement (PFA) with the Georgia Department of Transportation to receive \$600,000 of federal funding for preliminary engineering of the Winters Chapel Path Phase 2 between Charmant Place and Peeler Road. In October 2025, the city secured an additional federal grant of \$150,000 from the Atlanta Regional Commission (ARC) Transportation Alternatives Program for preliminary engineering. The city has already satisfied the local match requirement for the additional funds. The federal funding is managed by the Georgia Department of Transportation (GDOT) and requires approval and execution of the Supplemental Agreement to the PFA, which is attached.

DETAILS

The Winters Chapel Path project was first identified in the Winters Chapel Road Area Study adopted by Dunwoody and Peachtree Corners in 2015. The project is also identified in the Dunwoody Trail Master Plan as P17. In 2023, Dunwoody completed Phase 1 of the path on the west side of Winters Chapel between Dunwoody Club Drive and Charmant Place. Phase 2 will continue the path on the west side of the road southward from Charmant Place into Peachtree Corners and then back into Dunwoody ending at Peeler Road. The concept design contract was approved in May 2024, and federal funds were approved in April 2025 for design. The design phase of the project will follow the federal requirements for plan development with construction projected for 2028.

RECOMMENDED ACTION

Authorize the Mayor, City Manager, or designee to execute Supplemental Agreement No. 1 with the Georgia Department of Transportation to receive additional federal funding for design of Phase 2 of the Winters Chapel Path.

This Supplemental Agreement No. 1 to the Project Framework Agreement, ("Supplemental Agreement No. 1"), is made and entered into on this _____ ("Effective Date"), by and between the GEORGIA DEPARTMENT OF TRANSPORTATION, an agency of the State of Georgia, hereinafter called the "DEPARTMENT", and CITY OF DUNWOODY, GEORGIA, hereinafter called the "SPONSOR."

WHEREAS, the DEPARTMENT and the SPONSOR entered into a Project Framework Agreement dated, July 31, 2025, for Contract ID: 48400-425-PFAOPD2501965 hereinafter called the "ORIGINAL AGREEMENT", for the purpose of having the CITY OF DUNWOODY reimbursed federal funds for PI # 0019791, Winters Chapel Road fm Charmant Place to Peeler Road - Phase II, the project consists of a shared-use path along Winters Chapel Road between Charmant Place and Peeler Road in the cities of Dunwoody and Peachtree Corners, such work hereinafter called the "PROJECT", and

WHEREAS, the DEPARTMENT and the SPONSOR agree that additional funds are needed to complete preconstruction engineering (design) activities, hereinafter referred to as "PE".

NOW, THEREFORE, THE PARTIES mutually agree that for and in consideration of the mutual benefits to flow from each to the other the ORIGINAL AGREEMENT, shall be modified as follows:

1. The current Exhibit A, TIP/STIP Insert, shall be deleted in its entirety and replaced with the revised Exhibit A, attached hereto

2. The following attachments appended to this Supplemental Agreement No. 1 are hereby incorporated by reference into and made part of the ORIGINAL AGREEMENT, and shall have the same force and effect as if set forth in full therein:
