Subject: **Supplemental Agreement to the Project Framework Agreement with the Georgia Department of Transportation for the Village Crossing**

ACTION

Authorize the Mayor, City Manager, or designee to execute a supplemental agreement to the Project Framework Agreement with the Georgia Department of Transportation to receive additional federal funding for design of the Village Crossing.

SUMMARY

The original Project Framework Agreement (PFA) was executed on September 27, 2024 for \$250,000 in federal funding with a \$250,000 local match. On October 14, 2025, City Council approved acceptance of additional federal funds for \$600,000 with a \$150,000 local match. The city has secured an additional federal grant of \$1,000,000 from the Surface Transportation Block Grant (STBG) Program. This funding along with a local match of \$62,500 will be allocated to funding the design of a cycle track and sidewalks along Chamblee Dunwoody Road. The federal funding is managed by the Georgia Department of Transportation (GDOT) and requires approval and execution of a supplemental agreement to the PFA.

DETAILS

The 2011 Dunwoody Village Master Plan identified the Village Crossing project to construct sidewalks, cycle track, stormwater management, landscaped buffers, pedestrian crossing enhancements, and improved lighting.
