Subject: **Resolution of Commitment to Provide Local Matching Funds for Federal Funding Requested for the Winters Chapel Road Path Phase 2 Project**

ACTION

Authorize the Mayor, City Manager, or designee to execute all documents necessary and proper for a Resolution of Commitment to provide local matching funds for federal funding requested for the Winters Chapel Road Path Phase 2 project.

SUMMARY

The Atlanta Regional Commission (ARC) is seeking applications for projects to receive federal funding through the Transportation Improvement Program (TIP). ARC will select eligible projects through a competitive process. As part of the funding application, the city must provide a resolution demonstrating its commitment to supplying local matching funds.

DETAILS

Public Works staff recommends applying for additional federal funding for a project already in the city's Capital Improvement Program and included in the regional Transportation Improvement Program (TIP). The funding request will be for \$800,000 for the Right of Way phase and \$1,700,000 for the Construction phase of the Winters Chapel Path Phase II project. Since this is an existing project that is already budgeted in the CIP, the required local matching funds will not require any additional financial commitment from the city. Any federal funds received will replace city funds that are currently needed to complete the project.

RECOMMENDED ACTION

Authorize the Mayor, City Manager, or designee to execute all documents necessary and proper for a Resolution of Commitment to provide local matching funds for federal funding requested for the Winters Chapel Road Path Phase 2 project.

WHEREAS, the Atlanta Regional Commission (ARC) is currently accepting applications for federal funding for projects under the Surface Transportation Block Grant program (STBG), including Transportation Alternatives (TAP), ARC's Livable Centers Initiative (LCI) program, and the Carbon Reduction Program (CRP).

WHEREAS, the City of Dunwoody is committed to the implementation of the Winters Chapel Road Area Study and has completed the Winters Chapel Road Path Phase I project; and

WHEREAS, the principles of the Atlanta Region's Plan are to support a competitive economy, healthy and livable communities and world class infrastructure; and

WHEREAS, the construction of the bicycle and pedestrian improvements along Winters Chapel Road will extend the existing existing network and is integral element in creating the community envisioned in Winters Chapel Area Study.

NOW, THEREFORE BE IT RESOLVED that the Mayor and City Council of the City of Dunwoody hereby support the application for the Atlanta Regional Commission's TIP Project Solicitation and hereby authorize the City Manager and staff to execute all appropriate documents in pursuit thereof.

NOW, THEREFORE BE IT FURTHER RESOLVED that the Mayor and City Council of the City of Dunwoody agree that the City of Dunwoody will provide the required 20% local match for any federal funding received.
