Subject: **Supplemental Agreement No. 2 to the Project Framework Agreement with the Georgia Department of Transportation for the North Shallowford Road Path**

ACTION

Authorize the Mayor, City Manager, or designee to execute a supplemental agreement to the Project Framework Agreement with the Georgia Department of Transportation to receive additional federal funding for design of the North Shallowford Road Path project.

SUMMARY

The original Project Framework Agreement (PFA) was executed on August 31, 2022 with Supplemental Agreement No. 1 executed on January 27, 2025. The current design contract is \$1,534,000 including \$960,000 in federal funding. The city has secured an additional federal grant of \$400,000 from the Transportation Alternatives (TA) Program. This funding along with the local match will be allocated to funding the design of a shared use path along North Shallowford Road from Chamblee Dunwoody Road to Cotillion Drive. The federal funding is managed by the Georgia Department of Transportation (GDOT) and requires approval and execution of a supplemental agreement to the PFA.

DETAILS

The Georgetown Master Plan identified the North Shallowford Road Path project to construct shared use path, sidewalks, stormwater management, bike lanes, landscaped buffers, pedestrian crossing enhancements, and improved lighting.

This Supplemental Agreement No. 2 to the Project Framework Agreement, (“Supplemental Agreement No. 2”), is made and entered into on this _____ (“Effective Date”), by and between the GEORGIA DEPARTMENT OF TRANSPORTATION, an agency of the State of Georgia, hereinafter called the "DEPARTMENT", and THE CITY OF DUNWOODY, GEORGIA, hereinafter called the "SPONSOR.”

WHEREAS, the DEPARTMENT and the SPONSOR entered into an Project Framework Agreement dated, August 31, 2022 for Contract ID: 48400-425-PFAOPD2202300 hereinafter called the “ORIGINAL AGREEMENT”, for the purpose of having the SPONSOR reimbursed federal funds for PI # 0019209, N Shallowford Rd fm Chamblee Dunwoody Rd to Cotillion Dr-LCI, the proposed project is a 0.70-mile-long project that aims to provide pedestrian and bicycle accommodation by constructing a shared-use path along North Shallowford Road, such work hereinafter called the “PROJECT”, and

WHEREAS, the ORIGINAL AGREEMENT has been previously modified by the DEPARTMENT and the SPONSOR by Supplemental Agreement No. 1 dated February 27, 2025, and,

WHEREAS, the DEPARTMENT and the SPONSOR to agree that further changes to the ORIGINAL AGREEMENT as previously modified, are needed to complete preliminary engineering (design) activities, hereinafter referred to as “PE”.

NOW, THEREFORE, THE PARTIES mutually agree that for and in consideration of the mutual benefits to flow from each to the other, the ORIGINAL AGREEMENT, as modified by Supplemental Agreement No. 1 dated February 27, 2025, shall be modified as follows:

1. Exhibit A, dated February 27, 2025, shall be deleted in its entirety and replaced with Revised Exhibit A, attached hereto and incorporated herein.

2. Except as modified, changed or amended all terms and conditions of the ORIGINAL AGREEMENT, as modified by Supplemental Agreement No. 1 dated February 27, 2025, shall remain in full force and effect.

3. The WHEREAS clauses and Exhibits hereto are a part of this Supplemental Agreement No. 2 and are incorporated herein by reference.

4. The ORIGINAL AGREEMENT, as amended, constitutes the full, complete and entire understanding between the Parties.
